- Required Courses (6 hours): AGR 201 or AGR 203 or ANT 105; a Professional Practice capstone experience (398, 398A01, or 398A02), from a participating department or school arranged in consultation with the advisor or a co-Director.
- Elective Courses (12 hours): Plan of study approved by the advisor/director consisting of 12 hours of elective courses from at least three departments.
- No more than 9 hours may be selected from the student's major department.

3. Provide a description for the proposed program.

The proposed FOOD STUDIES MINOR at Illinois State draws upon existing and new courses from across campus. It is student-centered and flexible, using three Gen Ed courses as gateways to the Minor, and then allowing a student to compose a plan of study consisting of four courses (12 hours) of electives. To ensure the interdisciplinary nature courses only 9 hours of credits for the minor may come from the students' major department. Required credits include a supervised capstone experience, arranged in coordination with the minor directors and enrollment in either 398a01 Professional Practice: Internship/Coop or 398a02 Professional Practice: Research Experience in Anthropology or other relevent program.

The Minor is contemplated as an interdisciplinary minor. Program Co-Directors will be Gina Hunter (SOA), Kathryn Sampeck (SOA) and Noha Shawki (POL). Ryan Gray has offered to serve as the Minor's advisor. With three co-Directors we do not expect the management of the Minor or supervision of projects to be onerous and all administrative duties will be undertaken in addition to our regularly assigned workloads.

4. Provide a rationale of proposed program.

Food production and consumption intersect with key global issues, including human rights, hunger and malnutrition, water security, energy, public health, environmental sustainability, and climate change. Food can, therefore, be a lens through which to study and understand critical global problems, their interlinkages, their impacts on our lives and our communities. It can also help students understand a variety of social justice issues that we have to grapple with in the US domestic context.

Food Studies programs have been expanding in the US since the 1990s and many Illinois State faculty have scholarship in this emerging discipline. We have the capacity and expertise to offer our students a coordinated but flexible food studies curriculum. Additionally, the growing food movement in Central Illinois offers our students opportunities for service learning and community engagement projects. The capstone experience of this minor supports the university's commitment to civic engagement (Strategic Direction IV in Educate-Connect-Elevate, the university strategic plan). This growing local food movement also offers opportunities for co-curricular programs that complement a Food Studies curriculum, which can support the integration of curricular and co-curricular activities, which Educate-Connect-Elevate also calls for (Strategic Direction II). Moreover, a Food Studies program would also contribute to the emphasis in Educate- Connect- Elevate on promoting the development of interdisciplinary programs (Strategic Direction II).

5. Describe the expected effects of the proposed program on existing campus programs (if applicable).

The proposed minor draws on courses from nine programs across campus. Because of the diversity of courses offered, we do not expect much impact on any one course or program. The list of courses was developed in consultation with faculty and advisors from these programs at a March 2018 campus meeting and via email discussions. All program chairpersons have given their written consent to participate in the program with the current list of courses.

6. Provide a sample four year plan of study demonstrating that a student could realistically complete the program requirements in a specific number of semesters.

The minor requires 18 credit hours and can be completed easily in four semesters. A student's plan of study must be approved by the minor directors or advisor. The following are two possible plans of studies.

A nutrition/dietetics student interested in the social determinants of health might take the following courses:

To complete the Professional Practice requirements, students will enroll in ANT or POL 398 (depending on their Food Studies faculty advisor) or in the appropriate 398 course in their major discipline.
