-78 total hours required (including B.M. major course requirements).

-6 hours in MUS 205A01 and 205A02, with at least 2hours of 205A02. Students must request consent to register for MUS 205A02 from the composition faculty. When such a request is made, the composition faculty will conduct a review of the student's academic and artistic progress, including a portfolio of the student's compositions. The number of students given consent may vary depending on program capacity and qualifications of students in the pool. Students who are not granted consent may be advised to retake MUS 205A01 and request consent again.

-6 hours chosen from the following: MUS 303, 304, and 305.

-9 hours chosen from ATK 240, 340, 345, and 380 or other ATK courses with consent from Music Theory Coordinator.

-Completion of 3 hours of MUS 122 and demonstrate Level III Piano Proficiency.

-6 semesters (12 hours) of Applied Music on the major instrument from the following: MUS 131, 132, 133, 134, 135, 136, 137, 138, 231, 232, 233, 234, 235, 236, 237, 238. Of the 12 hours, at least 2 hours (1 semester) must be at the 200-lefvel. NOTE: For voice students, successful completion of MUS 127 is highly recommended before signing up for the 200-level jury.

-A grade of C or better is required in all courses in the major including specific requirements for this sequence.

3. Provide a description for the proposed program.

This new B.M. degree sequence will integrate several courses in arts technology into the music composition curriculum. Students will receive a foundation in traditional music

study. Upper division coursework in the ATK program will prepare them to create digital music appropriate for almost every modern media platform.

4. Provide a rationale of proposed program.

Many of our composition majors are interested in pursuing career opportunities in fields that require substantial knowledge of software and concepts taught in the Arts Technology program. In this new sequence, students will be able to take a mixture of courses in Arts Technology and traditional private composition lessons. There will be less applied music and piano proficiency required. This sequence should be attractive to music students interested in film music, sound design, and electro-acoustic composition.

5. Describe the expected effects of the proposed program on existing campus programs (if applicable).

Composition majors have been collaborating with students from the School of Art and the Arts Technology Program on multimedia projects for several years. Creating a New Media Composition sequence will strengthen such collaborations and enhance the educational experiences of students throughout the College of Fine Arts.

6. Provide a sample four year plan of study demonstrating that a student could realistically complete the program requirements in a specific number of semesters.

Comments from Version 3 from Aaron Paolucci (College Curriculum Committee Chair):

Some language in the Music Catalog under MAJOR IN MUSIC, B.M. is impacted by this new sequence, and needs to be revised to reflect the addition of this sequence (and forthcoming new sequences as well). We advise Music submits a catalog change that reflects this separately from the New Media Composition sequence proposal.

Suggested changes to this proposal:

1) Remove common MAJOR IN MUSIC, B.M. language from this proposal and start section #2 with the NEW MEDIA COMPOSITION sequence language only.

2) change language in #5 and #8:

(Due to the limited number of seats available in ATK courses, and due to the emphasis on music required for these ATK courses, additional faculty with expertise in digital audio platforms may be required (please see Financial Implications Form)


