MINOR IN JAZZ PERFORMANCE

- 24 hours in Music required.
- Available only to instrumentalists on the following instruments: Saxophone, Trumpet, Trombone, Guitar, Keyk
- All students pursuing a Minor in Jazz Performance must be accepted into the School of Music by passing a perf
- Required courses: MUS 101, 102, 103, 123, 157, 201, 218, 222, 228 and 2 hours traditional/classical Applied M
- All students pursuing a Minor in Jazz Performance are required to have a minimum of 4 semesters of MUS 110
- drum set players may substitute additional applied music hours for MUS 228.
- Special note for Music majors taking the Minor in Jazz Performance:

Numerous courses required for the minor will have been completed in fulfilling requirements of the major. Because only 9 hours from the major program may be counted toward a minor also within the School of Music, students must complete at least 15 hours of approved MUS course work that is not applied toward meeting any requirements of the major.

3. Provide a description for the proposed program.

The minor in jazz performance is available only to instrumentalists on the following instruments: saxophone, trumpet, trombone, guitar, keyboard, bass, or percussion. This sequence offers a curriculum for students who are especially interested in developing their performance abilities in the jazz style including jazz improvisation. The sequence of courses will give students a thorough understanding of the fundamental structures and concepts that jazz is built on with primary curricular emphasis placed on jazz improvisation, jazz theory, and jazz performing ensembles.

The following is the proposed breakdown of courses and credit hours:

40% Performance (10 credits minimum):

Applied Music (2)

Jazz Improvisation I (2)

Jazz Improvisation II (2)

Jazz Ensembles (4)

32% Academic (8 credits minimum):

Introduction to Jazz Performance & Pedagogy (2)

Mus 157 History of Jazz (3)

Mus 103 Computer Skills for Musicians (1)

Mus 222 Theoretical Foundations of Jazz and Rock Music (2)

28% Music Electives (6 credits minimum):

Additional Music Theory (6) (Academic prerequisites)

4. Provide a rationale of proposed program.

While the School of Music gets numerous inquiries every year about whether there is a sequence available in jazz, there is currently no such recognized program available. The minor in jazz performance would provide students interested in developing their jazz performing abilities with a tangible record (on their transcript) of their work in this discipline, which involves different training than traditional music.

Many music majors graduate with a large number of excess elective credit hours in music. For some students, jazz ensembles and jazz improvisation classes account for many of these extra credit hours. These students would benefit by being able to apply some of these credit hours towards the minor in jazz performance.

Additionally, the instructional capacity for the required new courses can be accommodated by existing faculty members with no need for additional funding.

5. Describe the expected effects of the proposed program on existing campus programs (if applicable).

Effects on existing campus programs should be mostly positive and relatively minor:

- 1) It is expected that music majors with a keen interest in jazz will find this minor particularly appealing and manageable, especially students in the following music sequences: BM in Performance, BM in Composition, BA/BS in Music Business, and BA/BS in Music. Students pursuing the BME would likely need an additional semester on campus to complete this minor.
- 2) The School of Music's ability to recruit quality undergraduate musicians will be improved with the offering of this minor.
- 3) If a significant number of non music majors were to enroll in this minor, an extra teaching load for some music faculty may result. However, admittance to this program will be contingent upon a successful audition by the applicant, preventing overload for music instructors.
- 4) Many music majors currently graduate with a large number of excess credit hours in music. For some students, jazz ensembles and jazz improvisation classes account for many of these extra credit hours. These students would benefit by being able to apply some of these credit hours towards the minor in jazz performance.
- 5) Through advisement within the School of Music, faculty can make sure that students do not "double count" more than 9 hours towards both a music major and the minor in jazz performance.

The 24 required hours for this minor should fit easily in to a four year program. The following is an example:
