Discussion:

Academic Impact Fund

Senator White: The Sense of the Senate Resolution that approved the Academic Impact Fund called for an evaluation after three years. This year is the end of that third year. The question is what happens during the fourth year while it is being evaluated. I propose that we extend what we have right now for a year while the evaluation takes place. The Provost suggests that the Budget Committee and members of the administration do the evaluation and the Budget Committee would bring forth a recommendation next year for the Senate to act on. That is the Sense of the Senate Resolution that the Budget Committee will bring forth at the meeting of March 8.

Senator Goldfarb: I did not like the idea of creating an ad hoc committee for this evaluation; the Budget Committee has been a committee that has said that it has been out of the discourse regarding budgetary issues. I will be meeting with them to review how the funds of the Academic Impact Fund were expended and the use of personnel. I will also review how the fund has operated and what my expectations are in relationship to it. The Budget Committee will share this information with the Senate. I will also send it to Senate members by e-mail.
