**Senator Crothers:** Beginning with the April 26 Senate meeting, we will start a more formal tradition of recognizing the members leaving the Senate, as well as recognizing incoming Senate members. We will distribute certificates to those leaving the Senate on April 26<sup>th</sup> and to new senators on May 10.

Technically, if the Information Items on the agenda do not become Action Items on Wednesday, they cannot be voted on as Action Items on May 10 by the new Senate, which technically has the right to review them again. **Senator Crothers:** The ones that I think may not move to action are the Involvement in Political Activities Policy and the Faculty Responsibilities to Students Policy, which are both attachments to the Code of Ethics.

**Senator Fazel:** The Rules Committee is really hoping to finish the ethics document. If there are a lot of concerns, would we bring those polices as Information Items again next year?

**Senator Crothers:** That is correct. They could be completed before the end of September by the new Senate. We can just hope that we get them done on the 26<sup>th</sup>.
