wanted to make that campus wide, it would not be extraordinarily expensive. Senator Borg stated that we should not continue administering an exam that the experts in writing consider obsolete.

Discussion:

Seating of the New Senate

The committee briefly discussed the seating of the new Senate. Executive Committee Members were in agreement that certificates should continue to be distributed to departing and newly-elected Senate members. Senator Borg volunteered to distribute certificates to those members leaving the Senate on April 25 while Senator Crothers read the list of names. Ms. James suggested that it might be better to distribute the certificates at the end of the meeting on April 25. For the May 9 meeting, Ms. James further suggested that Senator Borg call the names of the new members of the Senate and that the Student Body President give each new senator a certificate as they entered the meeting room at the beginning of the meeting.

Department Name Change

Senator Presley reported that he had approved the Department of Speech Pathology and Audiology's request to change its name to the Department of Communication Sciences. Provost Presley stated that there was a procedure or precedent by which he was to report this change to some committee of the Senate. Ms. James noted that the Senate's only involvement with changes of department names were those requests that involved changing a "department" to a "school". Those types of requests are reported to the Administrative Affairs and Budget Committee of the Senate.
